Car Collision. What Now?



Your actions following a crash can determine your long-term financial and physical health. Know what to do and what to say after a collision.

Talk to Ranz Injury Law first.



In Case of a Crash...

- ☒ **Stop** and move your vehicle to a nearby safe location.
- ☒ **Call for assistance** if anybody is injured. Assist the injured if possible.
- ☒ **Call the police.** They can record details and establish the cause of the collision.
- ☒ **Gather information** yourself using the adjoining checklist.
- ☒ **Be careful what you say.** Don't speculate about the cause of the collision and don't make statements to the police.
- ☒ **Call Ranz Injury Law.** Get legal advice first to protect your rights and ensure you are treated right.

- ☒ **Notify your insurance company.** But do not make a statement about cause or medical condition of anyone involved in the crash.
